

Restricted Judges Application

When applying to become a NSBA Judge, please remember the following:

- 1. Must be at least 25.
- 2. Must be a current NSBA member in good standing member to the year in which you apply.
- 3. Applicants must provide a copy of their judge credentials from one of the approved associations in Hunter/Jumper or Ranch discipline.
- 4. After the application is submitted, the Judges Committee will review all completed applications. Following the Judges Committee review, applicants will be notified as to whether they have been approved for judge status. Incomplete applications will not be reviewed by the Judges Committee.
- 5. If you are approved for judging status, your name will be added to the permanent judges list and it will be mandatory to complete a recertification session after your first year as a NSBA Judge.

Please remember to submit:

- 1. \$100 application fee (non-refundable)
- 2. A recent head and shoulder photo in judging attire (NOTE: Your application will be considered incomplete without a photo).
